Penalty ½: Tick or light touch of log; hind legs skipping or coming together during lead change; non-simultaneous lead change  
 Penalty 1: Hit or rolling log; out of lead more than one stride either side of the center point & between the markers; splitting the log(log between the 2 front or 2 hind feet at the lope; break of gait at the walk or jog up to 2 strides

Penalty 3: Not performing the specific gait or stopping when called for in the pattern; simple change of leads; out of lead at or before the maker prior to the designated change area or out of lead at or after the marker after the designated change area; additional lead changes anywhere in pattern; in pattern 1 & 3 failure to start the lope within 30 ft. after crossing the log at the jog; break of gait at walk or jog for more than 2 strides; break of gait at the lope

Penalty 5: Out of lead beyond the next designated change area; blatant disobedience including kicking out, biting, bucking and rearing

Penalty Score 0: Illegal equipment; willful abuse; off course; knocking over markers; completely missing log; major refusal; major disobedience or schooling; failure to start lope prior to end cone in patterns 1 & 3; 4 or more simple lead changes &/or failure to change leads; overturn of more than ¼ turn; head consistently carried too low consistently; over flexed, except in novice classes
